A BILL TO CREATE AN ORDINANCE ENTITLED:

“AN ORDINANCE ANNEXING CERTAIN ADJACENT AND CONTIGUOUS UNINCORPORATED AREA INTO THE CITY OF CENTRALIA, MISSOURI.”

WHEREAS, a verified petition received January 19, 2016 and signed by Thomas Patton and R. Eileen Patton (being the owners of all the fee interests of record in all the real estate hereinafter described) requesting annexation of the real estate hereinafter described into the City of Centralia, Missouri was presented on February 1, 2016 to the Board of Aldermen of the City of Centralia, Missouri; and

WHEREAS, the City of Centralia, Missouri Planning and Zoning Commission, after consideration during its meeting on February 4, 2016, recommended to the Board of Aldermen that the property described below belonging to the petitioners described above be voluntarily annexed into the City of Centralia, Missouri by petition; and

WHEREAS, said real estate as hereinafter described is unincorporated, and is adjacent and contiguous and compact to the existing corporate limits of the City of Centralia, Missouri; and

WHEREAS, a public hearing concerning said matter was held by the Board of Aldermen of the City of Centralia, Missouri at the City Hall Council Chambers, 114 S. Rollins, in Centralia, Missouri, at the hour of 7:00 p.m. on February 16, 2016; and

WHEREAS, notice of said public hearing was given by publication of notice thereof, on January 20, 2016 in the Centralia Fireside Guard, a weekly newspaper of general circulation in the City of Centralia and the County of Boone, State of Missouri, which said newspaper is qualified to publish legal matters; and

WHEREAS, at said public hearing, all interested persons, corporations and political subdivisions were afforded the opportunity to present evidence regarding the proposed annexation; and

WHEREAS, no written objection to the proposed annexation was filed with the Board of Aldermen of the City of Centralia, Missouri within fourteen days after the public hearing; and

WHEREAS, the Board of Aldermen of the City of Centralia, Missouri, does find and determine that said annexation is reasonable and necessary to the proper development of the City; and

WHEREAS, the City is able to furnish normal municipal services to the area described below within a reasonable time after annexation; and

WHEREAS the Board of Aldermen of the City of Centralia, Missouri finds that it is in the best interest of the City of Centralia, Missouri and its citizens to annex the property described below.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CENTRALIA, MISSOURI, as follows:

SECTION 1. Pursuant to the provisions of Section 71.012 of the Revised Statutes of Missouri, the following described real estate, being in an unincorporated area, is hereby annexed into the City of Centralia, Missouri, to-wit:

A portion of the parcel of property conveyed to Thomas Patton, by warranty deed dated May 10, 2006, and recorded in Book 2941, Page 19, Records of Boone County, Missouri described as:

A tract of land situated in the Northwest Quarter of the Northwest Quarter of Section 10, Township 51 North, Range 11 West, Centralia, Boone County, Missouri, being more particularly described as follows:

Commencing at a ½” rod set at the west 1/16th corner common to Sections 3 and 10 per Book 1147, Page 956, Records of Boone County, Missouri; Thence along the west 1/16th line of said Section 10, S01° 37’58”W a distance of 713.68 feet to the point of beginning; Thence leaving said line, N88° 12’29”W a distance of 180.0 feet; Thence S01° 37’58” W a distance of 90.0 feet to the North line of the current city limits, by the City of Centralia, Missouri Ordinance 2047 recorded in book 1473, page 870, Records of Boone County, Missouri; Thence along the current City Limits, S88° 12’29”E a distance of 180.00 feet; Thence N01° 37’58” E a distance of 90.0 feet to the point of beginning, containing 16,200 square feet more or less.

SECTION 2. The boundaries and limits of the City of Centralia, Missouri are hereby altered and extended so as to encompass and include the above described land lying adjacent and contiguous and compact to the existing corporate limits.

SECTION 3. The City Clerk of the City of Centralia, Missouri is hereby ordered to cause three certified copies of this Ordinance to be filed with the Boone County Clerk and three more certified copies of this Ordinance to be filed with the Boone County Assessor.

SECTION 4. The City Administrator and other pertinent personnel of the City of Centralia, Missouri are hereby authorized and directed to revise all maps, directories, drawings, plats and other appropriate documents to conform to the altered corporate limits in the City of Centralia, Missouri as herein provided.

SECTION 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 6. This ordinance shall take effect and be in full force and effect from and after the date of its passage and approval.

ORDINANCE NO. \_\_\_\_\_

A BILL TO CREATE AN ORDINANCE ENTITLED:

“AN ORDINANCE AMENDING CHAPTER 31 OF THE CENTRALIA CITY CODE RELATING TO THE ZONING OF CERTAIN LAND BROUGHT INTO THE CITY OF CENTRALIA, MISSOURI BY ANNEXATION; AND AMENDING THE ZONING MAP ACCORDINGLY.”

WHEREAS, the City of Centralia, Missouri Planning and Zoning Commission, after public hearing and consideration on February 4, 2016, voted by a vote of 9 to 0, with no abstentions, to recommend to the Board of Aldermen, in accordance with Section 31-7 of the Centralia City Code, that Chapter 31 of the Centralia City Code be amended so that the designated portion of a parcel of land described in Section 1 of this ordinance when annexed into the City of Centralia, Missouri, be placed in Zone District B-2; and

WHEREAS, in accordance with Section 31-9 of the Centralia City Code, notice of a public hearing regarding the recommended amendment was given by the Board of Aldermen, stating that the hearing would be held on February 16, 2016 at 7:00 p.m. in the Council Chambers of the Centralia City Hall, said notice having been published in the January 20, 2016 issue of the Centralia Fireside Guard, a weekly newspaper of general circulation in Centralia, Missouri; and

WHEREAS, a public hearing was held at 7:00 p.m. February 16, 2016 in the City Hall Council Chambers in Centralia, Missouri, by the Board of Aldermen, at which hearing all parties in interest and citizens were given an opportunity to be heard in relation to the recommended amendment; and

WHEREAS, no citizen(s) appeared at the hearing, and no written protest has been made to such proposed amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CENTRALIA, MISSOURI, as follows:

SECTION 1. The following described tracts of land, comprising land recently annexed into the City of Centralia, Missouri, by Ordinance No. \_\_\_\_\_, shall be placed in Zone District B-2, per Section 31-3 of the Centralia City Code:

A portion of the parcel of property conveyed to Thomas Patton, by warranty deed dated May 10, 2006, and recorded in Book 2941, Page 19, Records of Boone County, Missouri described as:

A tract of land situated in the Northwest Quarter of the Northwest Quarter of Section 10, Township 51 North, Range 11 West, Centralia, Boone County, Missouri, being more particularly described as follows:

Commencing at a ½” rod set at the west 1/16th corner common to Sections 3 and 10 per Book 1147, Page 956, Records of Boone County, Missouri; Thence along the west 1/16th line of said Section 10, S01° 37’58”W a distance of 713.68 feet to the point of beginning; Thence leaving said line, N88° 12’29”W a distance of 180.0 feet; Thence S01° 37’58” W a distance of 90.0 feet to the North line of the current city limits, by the City of Centralia, Missouri Ordinance 2047 recorded in book 1473, page 870, Records of Boone County, Missouri; Thence along the current City Limits, S88° 12’29”E a distance of 180.00 feet; Thence N01° 37’58” E a distance of 90.0 feet to the point of beginning, containing 16,200 square feet more or less.

SECTION 2. That the Zoning District Map dated July 20, 1987 and adopted on that date, as

provided for in Section 31-3 of the Centralia City Code, shall be amended and changed so that it will provide that the land described in Section 1 of this ordinance shall be in Zone District B-2, and such amended Zoning District Map after such changes and all previous changes shall be and is hereby adopted as the Zoning District Map.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in full force and effect from and after the date of its passage and approval.

### ***February 2016 Activity Report***

1. Daily trash collection
2. Weekly cardboard and bi-weekly curbside recycling collection
3. Had 1 double trash route this month
4. Loaded and hauled off 2 loads of plastic to City of Columbia recycling facility
5. Assembled and delivered 5 trash carts to city residents
6. Took street sweeper to Meyers Truck Service in Mexico for service, and repairs
7. Piled up brush and leaves at the drop off site and cleaned up trash several times
8. Loaded and hauled off 2 loads of plastic to Ryan Ent. in Millersburg
9. Hooked up snowplow on dump truck #4 after spreader repairs, and sprayed conveyor chains on both spreaders
10. Got a load of dumpsters and put lids and decals on them and then put them into the shed
11. Replaced all of the bolts on the snowplow cutting edge on truck #10
12. Cleaned the backhoe and the loader
13. Met with Clarence Hoskins about extending driveway culvert
14. Met with Mr. Davidson about work going on along Ivy Lane
15. Did 23 locates this month
16. Serviced and cleaned the mower tractor #81, pickup #18, pickup #25, truck #10
17. Loaded and hauled off 2 loads of recycling to City of Columbia recycling facility
18. Cleaned up Parks parking lot where we had piled snow
19. Cut off and lowered inlet, and installed new grate on Pratt st.
20. Had Central Metals from Mexico set a roll off dumpster and we loaded scrap metal pile into it
21. Delivered 20 barricades to the Baptist Church for an event and then picked up afterwards
22. Added rock and smoothed up several alleys and shoulders
23. Spent a couple days doing sign maintenance
24. Delivered new dumpster to Ritchie's and got rid of the old one
25. Spent several days this month hauling off the debris pile at the landfill to several farmers outside of town
26. Cleaned up the shop
27. Loaded a dump truck with mulch 11 times
