### ORDINANCE: Fixing the Compensation of Certain Employees of the City of Centralia, Missouri

Russell said the City Code has an established position for a Director of Public Works and Public Utilities, but there has not been anyone in the position for many years. There was a Director of Public Works and Public Utilities under former City Administrator Lynn Behrns for about ten years, and having someone in that position would be very beneficial to the City. In order to be fiscally responsible, this ordinance would promote current Water & Sewer Dept. Foreman Mike Forsee to the position of Director of Public Works and Public Utilities and current Water & Sewer Dept. Lead Equipment Operator Matt Rusch to Water & Sewer Dept. Foreman, which means the City would be promoting from within and not adding another person to the payroll.

Alderman Wilkins presented a bill marked and designated as bill no. 2242 to create an ordinance entitled "AN ORDINANCE TO FIX THE COMPENSATION OF CERTAIN EMPLOYEES OF THE CITY OF CENTRALIA, MISSOURI." Alderman Wilkins moved that it be placed on its first reading by title only. Before the bill was introduced copies of the bill were made available for public inspection. Motion was seconded by Alderman Hudson and motion carried unanimously. The bill was then read by title only. Alderman Wilkins moved the bill be placed on its second reading. This motion was tabled due to revisions that needed to be clarified by City and Phynx Fiber and to be placed on the August 6th agenda.

ORDINANCE: Calling November 6, 2018 Municipal Election to Impose a City Wide Public Safety Sales Tax of One-half Percent

Mayor Grenke spoke of July 5<sup>th</sup> meeting in Jefferson City July 5th concerning the signing of the Public Safety Sales Tax Bill by Governor Parson.

PLACE ON THE NOVEMBER 6, 2018 BALLOT THE PROPOSITION OF "SHALL THE CITY OF CENTRALIA IMPOSE A CITYWIDE SALES TAX OF ONE-HALF OF ONE PERCENT FOR THE PURPOSE OF IMPROVING THE PUBLIC SAFETY OF THE CITY?"
